GENERAL ECH PRICING INFORMATION

Prices and GST

Prices are effective from 1 August 2025 and are subject to change. All prices in this price list exclude GST. All prices are for services delivered directly by ECH to individual members of the public and are GST free if delivered as part of a Home Care Package (HCP). GST may apply where not Government funded, such as and Domestic Assistance, and User Pay.

Standard Service Hours and Service Time Frames

ECH provides services between 7am to 8pm Monday to Friday except where otherwise specified. To ensure all ECH clients receive quality care, all services are scheduled within a one-hour time frame between the days and times shown for each service. Services can be arranged outside of the standard service hours and on Public Holidays, upon request, at an additional cost. If your appointment time extends over the duration of the booked appointment time, please note you will be charged in extra 30-minute increments.

Domestic Assistance services will be provided within a one-hour time frame regardless of day, with a minimum charge of one-hour regardless of appointment length.

Public Holidays

Public Holidays will be charged at a higher Public Holiday rate except where specified otherwise. Not all services are available on Public Holidays.

Bookings and Cancellations

ECH applies a strict bookings and cancellations policy. Bookings and cancellations are essential for all services including appointments, exercise classes and events. Notification of cancellation is required at least 24 hours in advance of the scheduled appointment, group program, event or service. Where timely cancellation is not received, the full price may be applied (excluding exercise classes). If you need to attend to an unplanned hospitalisation, medical emergency or family emergency you will not be charged.

Home Services

Domestic Assistance

Standard service hours are Monday to Friday between 9am to 5pm. Minimum charge of one-hour regardless of appointment length. Utilises clients' own cleaning equipment and products. Does not include oven or window cleaning. #Any travel that occurs within the scheduled appointment will be charged at \$1.30 per kilometre.

Personal Care and Support

Standard service hours are Monday to Friday between 7am to 8pm. These services can be arranged out of standard hours upon request. #Any travel that occurs within the scheduled appointment will be charged at \$1.30 per kilometre.

Respite

Day Programs

*Rates are based on the arrive and depart times shown to ensure appropriate staff coverage. An assessment will be undertaken during your first attendance to determine ongoing suitability of the Day Program for your needs. This will be charged at the Day Program standard rate of \$29 and is non-refundable. Attendance can be fully funded via a Home Care Package, on a self-funded basis or partially funded via an approved CHSP program. May not be available on public holidays. Transport to and/or from can be arranged and will be discussed with you prior to booking.

^Transport 1 and 2 way not currently available to ECH Day Program Happy Valley.

Community Connections

All participants are required to complete an ECH assessment prior to attending. For more details on the current schedule, please visit ech. asn.au/events. *Includes morning tea, lunch and any applicable entrance fees. Bus Trip attendance can be fully funded via a Home Care Package or on a self-funded basis. Cost of \$195 per person includes snacks, lunch, and any applicable entrance fees. CHSP clients can access a subsidised rate of \$53 but will need a referral from My Aged Care. An ECH staff member will contact you to book an assessment once a My Aged Care referral is received. Minimum four participants required per bus trip.

Wellness Services

Initial Assessment includes: preparation, clinical assessment & intervention, documentation, and follow-up communication with your nominated contact person and/or health care team. Initial consultations include a thorough assessment and discussion about your condition and goals. It also incorporates ordering equipment and consumables as required.

Standard and Long Consultations includes: preparation, clinical assessment & intervention, documentation, and follow-up communication with your nominated contact person and/or health care team. Includes ordering equipment and consumables as required. Your treating allied health professional will recommend a long consultation if needed to provide enough time for treatment.

If you have private health insurance you may be able to seek rebates from your provider, or if you are aged 65 years or over, you may qualify for financial assistance from the Government via a Home Care Package (HCP). If you have a valid referral for the Medicare Chronic Disease Management Program or if you are eligible to access services through DVA, ECH claim your service directly with Medicare/DVA and you will have no out-of-pocket expenses. Government funding may be available to subsidise Allied Health Services upon assessment via My Aged Care. All visits are priced at a per visit rate, travel time is incorporated into the rates shown for home visits.

Podiatry

*Nail Surgery (2hr surgery and 30 min follow up consult) is charged at \$368. CHSP clients can access a subsidised rate of \$74.

Massage Therapy

*Massage appointments include treatment time, set-up, pack-up and documentation time.

Personal Training:

*Exercise physiologist appointment and referral required to access this service.

Group programs

*If you do not attend an ECH Allied Health Program for 6-11 months, you will need an ECH Exercise Physiologist Standard Consult for \$90. A review is required every 12 months, priced at the ECH Exercise Physiologist standard consult rate of \$90. CHSP clients can access a subsidised rate of \$25. If you do not attend an ECH Allied Health Program for over 12 months, you will need an ECH Exercise Physiologist Initial Assessment for \$121. CHSP clients can access a subsidised rate of \$35. If you have private health insurance you may be able to seek rebates from your provider, or if you are aged 65 years or over, you may qualify for financial assistance from the Government via a Home Care Package (HCP).

#Strength for Life is a COTA SA registered program – capped at \$14. Strength for Life initial assessment is \$70 with a Physiotherapist or Exercise Physiologist and is required to be undertaken prior to commencement.
