## **Prices and GST**

Prices are current from 1 August 2025 and are subject to change. All listed prices exclude GST. Services delivered under a Home Care Package (HCP) are GST-free. GST may apply to services not funded by the government, such as Garden Maintenance and Domestic Assistance.

## **Standard Service Hours and Appointment Timeframes**

ECH services are available Monday to Friday, between 7:00am and 8:00pm, unless stated otherwise. Home Services are scheduled within a one-hour start window and are delivered in 30-minute blocks.

Services outside standard hours or on public holidays can be arranged and will incur extra charges. If a service runs over time, additional charges apply in 30-minute increments. Charges are based on the scheduled duration of the visit, not the actual time delivered. If a service finishes early, the full scheduled time will still be charged.

## **Bookings and Cancellations**

ECH maintains a bookings and cancellations policy. Bookings are essential for all services, including individual appointments, exercise classes, group programs, and events.

To avoid incurring charges, cancellations must be made at least 24 hours in advance of the scheduled service. If notice is not provided within this timeframe, the full service fee may apply. Exceptions are made for unplanned hospitalisations, medical emergencies, or family emergencies.

#### **RESPITE SERVICES**

#### **Day Programs**

An assessment will be undertaken during your first attendance to determine ongoing suitability of the Day Program. Day Program is charged at standard rates regardless of arrival / departure time. Transport may be available upon request. Programs include morning tea, lunch, and snacks. Day Program is not available on Public Holidays.

For ongoing Day Program attendance, reviews are conducted annually, if you've not attended a Day Program for three months or as required.

## **Community Engagement**

A suitability assessment is required prior to attending our community engagement groups. Visit ech.asn.au/events for current schedules. Group programs may include morning tea/snack, lunch, and any applicable entrance fees. Bus trips require a minimum of 4 participants per trip.

#### **WELLNESS SERVICES**

All visits are priced at a per visit rate.

### **Initial Consultations**

Include preparation, clinical assessment, documentation, and communication with your nominated contact or healthcare team. May include ordering equipment or consumables.

#### **Standard and Long Consultations**

Include preparation, clinical assessment & intervention, documentation, and follow-up communication with your nominated contact or healthcare team. Includes ordering equipment and consumables as required. Long consultations are recommended when additional time is needed for treatment.

#### **Home Consultations**

Travel time is included in home visit rates

ECH offer Nail surgery (a 2-hour procedure + 30-minute follow-up) priced at \$368

## Massage Therapy

## Allied Health Group Programs

To join an Allied Health group program, an Initial In-Clinic Consult with the relevant Allied Health Professional is required.

An initial in-clinic consultation is also required if a client has been absent from a group programme for more than twelve months. For ongoing group attendance, a standard in-clinic consultation is required

- every 12 months, or
- if you have not attended a group for more than three months
